Important changes to your benefits! Please read carefully.

DEATH and ACCIDENTAL DEATH/DISMEMBERMENT BENEFITS:

Due to an insufficient increase (35 cents per the Agreement For The Restructuring Of The YRC Worldwide, Inc. Operating Companies as ratified on or about October 30, 2010) in the level of contributions to be made by YRCW, effective August 1, 2011, the Death Benefit and the Accidental Death/Dismemberment Benefit payable under Section 17 of Plan 13Y will be reduced.

As of August 1, 2011, \$5,000 will be payable upon the death of an eligible Participant and \$1,000 will be payable upon the death of the Participant's eligible Spouse or Child. In addition, in the event of the accidental death of the Participant, \$5,000 will be payable (with proportionately reduced benefits for accidental dismemberment). Prior to August 1, 2011, \$10,000 is payable upon the death (and accidental death, if applicable) of the Participant and \$2,000 upon the death of a Spouse or Child.

NOTE: For a full description of these Benefits, please see the Summary Plan Description. All other Benefits are unchanged at the present time. All Plan rules regarding Eligibility, Plan limitations, and Plan rules, policies and regulations continue to apply.
