## IMPORTANT INFORMATION about the Multiemployer Pension Reform Act of 2014 as It Pertains to the Central PA Teamsters Defined Benefit Plan

A number of participants have contacted the Fund Office with concerns about the Multiemployer Pension Reform Act of 2014, enacted as part of the budget bill. We want you to know that this legislation addresses multiemployer defined benefit plans which are in critical and declining status and projected to be insolvent in 20 years. The Central Pennsylvania Teamsters Defined Benefit Plan is not in critical or declining status. nor is it facing insolvency. In fact, the current actuarial projections predict that the Fund will be fully funded in less than 10 years. In addition, the new law has no application to the Retirement Income Plan which is a defined contribution plan.

As you know from prior notices, and as is true today, the Central Pennsylvania Teamsters Defined Benefit Plan is currently in "green" status. That means that the pension benefits paid today, and the benefits that you are accruing today, are not affected in any way by the passage of the Multiemployer Pension Reform Act. Although other pension plans may be faced with reducing or suspending benefits under the new law. the Trustees of our Fund look forward to continuing to work towards full funding and providing the type of benefits that allow for a more comfortable and secure retirement

## Sun Life Death/AD&D Program Offers Additional Benefits

The Fund's Death and Accidental Death and Dismemberment (AD&D) benefits are provided through Sun Life. Your collective bargaining agreement spells out whether or not your coverage includes Death and AD&D benefits through the Central PA Teamsters Health and Welfare Fund and, if so, under which Plan level you are covered.

In addition to Death and AD&D. Sun Life offers additional benefits to those who are covered:

- On-Line will preparation through an easy-to-use secure website, www.EstateGuidance.com. In addition, Claimant Support Services offers no-cost, objective financial planning, legal information and emotional support through ComPsych if you or your family member has filed a claim with Sun Life.
- Emergency Travel Assistance if you have a medical emergency while you are 100 miles or more from home, no matter where you are in the world. Assistance is provided by pre-qualified, English-speaking professionals who can provide medical consultation, hospital admission, critical care monitoring, emergency medical evacuation, transportation to return home, lost prescription assistance and legal and interpreter service.
- Identity Theft Protection through Assist America's SecurAssist Identity Protection Program.

# Know Your Health & Welfare Plan

The Health and Welfare Fund frequently receives questions on the topics below. Additional information on these topics is available in your Summary Plan Description or by visiting the Fund website.

- 1. **Dental Implants** All requests for dental implants must be submitted for pre-determination for review under the implant policy. Failure to do so could mean higher out of pocket expenses.
- 2. **Health Savings Accounts for dependents** If your spouse (or eligible dependent) is covered under a high-deductible health plan with a health savings account (HSA), this spouse or dependent may not be covered under the Central PA Teamsters Health and Welfare Plan. If your employer pays on a Component basis, the Employer will not be responsible for contributions for this spouse or dependent.
- 3. **Motor Vehicle Accidents** -The Fund will consider payment of medical expenses only after the benefits from the auto insurance carrier have been exhausted. In addition, the Fund will not provide coverage for Short Term Disability Benefits (except for the first 5 days of missed work). Contact your auto insurance carrier to make sure that your policy includes payment for missed work due to injuries sustained in an auto accident.
- 4. **Illegal Acts** -The Fund does not cover medical services rendered as a result of your committing an illegal act (misdemeanor or felony). This includes driving while intoxicated (DUI).
- 5. **Change in Family Status** Please review your beneficiary designation if there is a change in your family status. Please notify the Fund if you get married, divorced, are widowed or have a child. The Fund does not allow divorced spouses to continue to be covered under the member's coverage.
- 6. **Moonlighting** -The Fund does not cover participants or eligible dependents for illness or injuries that occur as a result of performing non-covered employment for wage or profit.
- 7. **Dependent Daughter Pregnancies** -The Fund does not cover medical expenses associated with a dependent's pregnancy.
- 8. **Address Change:** Please remember to contact the Fund office if your address changes.

## **Dental Predetermination**

Predetermination enables you and your dentist to know in advance what the Delta Dental payment will be for any service that may be in question.

Delta strongly recommends a predetermination if total charges are expected to exceed \$300.

Your dentist should submit the predetermination request before performing services.

Delta acts promptly in returning the predetermination voucher to your dentist (with a copy to you), explaining patient eligibility, scope of benefits, and the period of time for completion of services.

Delta's payment of the predetermined amount is dependent upon continued participant eligibility. Payment may be reduced due to coordination of benefits with other coverage for which the patient is eligible.

Once the service is completed, a claim with service dates and signatures should be submitted to Delta for prompt payment.

# The Women's Health and Cancer Rights Act of 1998

Under a federal law called the Women's Health and Cancer Rights Act of 1998, the Fund is required to provide you with an annual notice of your rights under this Act. Please consider this information as the annual notice for 2015 of your rights under this important federal law.

The Women's Health and Cancer Rights Act requires the Fund to provide benefits for mastectomy-related services, including reconstruction of the breast on which the mastectomy was performed and surgery to achieve symmetry between the breast, prostheses, and complications resulting from a mastectomy, including lymphedema. Any Fund deductibles and co-payments that apply to other conditions also apply to the treatment related to the mastectomy. You should feel free to contact the Fund Administrator if you have any questions about your coverage. You can reach the Fund Administrator at 610-320-5500.



# Know Your Pension Plan

The Pension Fund frequently receives questions on the topics below. Additional information on these and other topics is available by visiting the Pension section of the website. When you are ready to apply for your pension, please refer to the "Important Items to Remember" section of the website under Pension for additional information.

- 1. Beneficiary Updates/Change in Marital Status Please review your beneficiary designation if you change your marital status. Please notify the Fund if you get married, divorced, or become widowed. If you get divorced, please forward a copy of the divorce decree. You will need to complete a new beneficiary form for your Pension Benefits after your divorce is finalized. If you become widowed, you will need to forward a copy of the death certificate and also complete a new beneficiary form. Downloadable beneficiary forms are available on the Fund's website. You cannot name your pet as a beneficiary.
- 2. **Retirement Applications** Contact the Pension Fund three months prior to your retirement date to begin the application process (6 months if you have time in another Fund and are applying for a reciprocal pension). The Pension Fund offers appointments to assist you with completing your Application for Pension paperwork. Please be sure to review your benefit options on your paperwork so that you are familiar with them prior to your appointment.
- 3. **Your Retirement Income Plan (RIP) 1987** balance is updated by the 15th of each month and subject to net gains or losses through the last day of the month in which your application is approved for payment.
- 4. **Power of Attorney** If you cannot handle your own affairs, you must provide the Fund with a Durable Power of Attorney before any information can be given to the person who you designate to handle your affairs.
- 5. **Pension Checks** Your checks from the Defined Benefit Plan (or monthly installments from the Retirement Income Plan if elected) are dated the first of each month. If you elect direct deposit, your check will be deposited on the first business day of the month. For example, if the first of the month falls on Sunday, your check will be deposited on Monday.
- 6. **Website** Please visit the website for Summary Plan Descriptions, Forms and Notices, Important Items to Remember or to view your RIP 1987 balance.
- 7. **Signatures on Fund Documents** Please sign all Fund documents with your legal name, which must match what is on file with the Fund Office. Please be sure to use your full name (no nicknames) and suffix (Jr., Sr., III), if applicable.



In order for someone to request or receive information on a Participant and/or Beneficiary of the Pension Fund, a Power of Attorney document is required to be on file with the Fund. The Health and Welfare Fund requires a medical Power of Attorney. This article addresses the Power of Attorney as it pertains to the Pension Fund.

A "Power of Attorney" is a written document in which an individual, referred to as the "Principal," designates an individual, referred to as the "Agent," to exercise enumerated powers and perform covered acts for the sole benefit of the Principal. The Principal must be eighteen years of age or older to execute a Power of Attorney and also possess the mental capacity to understand the purpose of the document and appoint Agent(s).

Pennsylvania has enacted changes to the laws governing financial Powers of Attorney through Act 95, which was signed into law in July 2014. Power of Attorney documents executed prior to these changes are still valid so long as these documents meet the statutory requirements in effect at the time of execution. However, you may wish to have your document reviewed by an experienced attorney to determine if changes are necessary and to gain an understanding of the present options available.

It is important for the Principal to select an Agent who is trustworthy and competent to handle the Principal's affairs. A Power of Attorney is in effect only during the Principal's lifetime. Upon the Principal's death, the designated Agent no longer has authority to act under the document.

# Pension Fund Power of Attorney Update

The Power of Attorney document contains a special "Notice" that is found on page 1 of the document. This Notice outlines the broad powers that the Principal is giving to the Agent under the document, such as making decisions regarding property, finances, management, banking, business and various other matters on behalf of the Principal. This Notice has now been amended to warn that the Agent may give away the Principal's property or change how the property is distributed at the Principal's death.

All Financial Powers of Attorney, executed after January 1, 2015, must be signed by the Principal in the presence of a notary and two independent witnesses, who are eighteen (18) years of age or older. If the Principal is unable to execute the document, the amendments allow another individual to sign on the Principal's behalf at the direction of the Principal.

The Agent must act in good faith and in the Principal's best interest. Under the amendments, the Principal must consider which duties the Agent can perform and clearly identify the scope of the Agent's authority under the document.

In addition, the Agent must sign a special form acknowledging certain responsibilities. This Acknowledgment has been amended to state that the Agent will act in good faith and in accordance with the Principal's reasonable expectations to the extent that these expectations are known to the Agent. It is important for the Principal to have discussions with his or her Agent regarding such issues as how to manage assets, how gifts are to be made, and the Principal's expectations concerning illness and care.

While we can not predict whether we will have diminished mental capacity or become physically disabled as we age, it is important to prepare for these events and have a Power of Attorney document prepared. An experienced attorney can create a document which fully addresses your needs and expectations.

Compare any provider bills with your Explanation of Benefits (EOB) before you pay an outstanding balance. When you receive a doctor's or dentist's bill reflecting a balance due, please compare the bill with the Explanation of Benefits (EOB) you receive from the Fund. Do not pay any balances until after you have received and reviewed the EOB. The estimated balance on a bill generated before the claim is paid by the Fund may not be correct.

Please note: the EOB reflects any co-pay amounts associated with the medical treatment, whether or not the co-pays were actually paid at the time of treatment.

If you have any questions about a claim, be sure to contact the Health & Welfare Fund.

# SILENT SYMPTOMS OF PRE-DIABETES

**BLURRY VISION**: Sudden spikes and dips in your blood sugar (which are common in those with pre-diabetes) can impair your eye's ability to bend and focus, leading to blurred vision. The blurriness should go away once you get your sugar levels back into normal range.

**EXCESSIVE THIRST**: One of the more well-known signs of pre-diabetes and diabetes, excessive thirst occurs in response to the sur-



plus sugar in the blood. Your body attempts to flush the excess into the urine, which means you'll need to go more often than usual. This is turn can cause dehydration, making you feel thirsty.

**STUBBORN WOUNDS OR INFECTIONS**: High blood sugar can slow your circulation, so skin takes longer to repair itself. As a result, minor bruises and cuts might take longer than usual to heal. The condition can also promote the growth of bacteria and fungi, which may lead to repeat infections such as urinary tract infections.

**EXTREME FATIGUE**: Your body uses blood sugar for fuel. But pre-diabetes causes insulin resistance, which means your body isn't able to efficiently convert the glucose in your blood into energy, leaving you with severe fatigue—and sometimes even flu-like symptoms.

**SUDDEN, UNEXPLAINED WEIGHT GAIN OR LOSS**: When the body is unable to get the energy it needs from blood glucose, it starts burning other things for fuel, resulting in weight loss, even if you're not on a diet or working out. On the other hand, insulin resistance can make you feel hungry, which can cause weight gain.

**DARKENED AREAS OF SKIN**: High Insulin levels can speed the rate at which skin cells reproduce, leading to a condition called acanthosis nigricans. It occurs when skin on the back of the neck, under the arm, or in the creases of your elbows to darken and take on a smooth or velvety feeling.

#### **IDENTITY THEFT**

When your private financial information gets into the wrong hands, the consequences can be devastating. Yet there are many ways you can help protect yourself on a daily basis, from taking precautions while online to checking your credit report periodically.

If you should fall victim to identity theft, it is important that you act quickly. Contacting the correct agencies and filing the necessary reports will go a long way toward minimizing any damage to your financial wellbeing.

#### Who to Contact

**CREDIT BUREAUS**: Immediately contact the fraud departments of each of the credit bureaus listed below. Alert them that you are a victim of identity theft, and request that a fraud alert be placed in your file. You can also request a security freeze, preventing credit issuers from obtaining access to your credit files without your permission. This prevents thieves from opening up new credit cards in your name.

**LAW ENFORCEMENT**: Report identity theft to your local police department. If the crime occurred somewhere other than where you live, you may wish to report it to law enforcement there as well. The police will create an "identity theft report" and you can request a copy.

**FEDERAL TRADE COMMISSION (FTC)**: The FTC does not investigate identity theft cases, but they can share information that you give them, such as the identity theft report number, with investigators nationwide. # ROUTINE PHYSICALS AT URGENT CARE FACILITIES NOT COVERED

The Fund has contracted with Urgent Care facilities to cover the treatment of illness and injuries only. The Fund has not contracted with Urgent Care facilities to cover routine physicals for adults or children. Therefore, the Fund will consider payment for the treatment of illness and injuries at an Urgent Care facility, but will not pay for routine physicals.

In order to receive Fund coverage for routine physicals for yourself or your eligible dependents, please select treatment with a Primary Care provider, and not at an Urgent Care facility.

If you need assistance in locating a Primary Care provider, you may visit the Fund website, click on Health and Welfare, and select "Providers" to do a provider search. Or you may contact the Health and Welfare Fund.

#### Vision Services for Medical Conditions

Davis Vision only pays claims for well vision checkups in order to determine the need for glasses or contacts. If you are in need of a vision visit for a medical condition, such as glaucoma, the Fund would consider that visit payable under the medical provisions of your plan. Office visit services provided by a participating provider would be subject to the appropriate specialist co-pay. If the provider that you utilize is a non-participating, the Fund will pay up to the usual and customary fee minus the appropriate specialist co-pay. If the doctor also performs a charge for a refraction, the refraction would not be payable under the medical provisions of your plan, and would be covered only if you are eligible for vision coverage through the Davis Vision program. Before you decide which provider to utilize, you must consider the reason for which the visit is needed. Please contact the Fund Office if you are in doubt about the network that you should be using to select a provider.

### Reminder: Health and Welfare Plan Co-pay Changes Became Effective January 1, 2012

Just a reminder that, effective **January 1, 2012**, the Health and Welfare Fund increased participant copay amounts for Office Visits, Hospital, Out-Patient Surgery, Emergency Room Visits and Ambulance/Life Flights as follows:

- \$5 increase in Office Visit Co-payment (this includes rehabilitative, mental nervous and substance abuse visits if your plan provides those benefits). In-Network Primary Care visit co-pays increased from \$15 to \$20 and In-Network Specialist visit co-pays increased from \$25 to \$30.
- Inpatient Hospitalization Co-payment: \$100 per admission\*
- Outpatient Surgery Co-payment: \$100
- Emergency Room Co-payment Increased from \$50 to \$100\*
- Ambulance/Life Flight Co-payment: \$100

\*If you visit the Emergency Room and are admitted to the hospital from the Emergency Room, you will be charged only one \$100 co-pay.

### **Employer Group Coverage Requirements under USERRA**

The Uniformed Services Employment and Reemployment Rights Act (USERRA), prohibits discrimination against persons because of their service in the Armed Forces Reserve, the National Guard, or other uniformed services.

USERRA requires that employees who are called up to active service and who are eligible for their employer's group health coverage must be allowed to continue their health coverage for themselves, their spouse and their dependent children. Individuals electing continuation of coverage on or after December 10, 2004 can elect coverage for up to 24 months. Prior to December 10, 2004, eligible individuals could elect coverage for up to 18 months.

The Act also requires that employers provide an annual notice of USERRA rights and obligations to employees entering military service. This notice requirement can be met by posting the notice in a location where the employer customarily places notices to employees. The requirement also applies to unions that operate hiring halls.
