# IMPORTANT CHANGES TO YOUR PRESCRIPTION BENEFITS EFFECTIVE MARCH 8, 2016 SUMMARY OF MATERIAL MODIFICATION ("SMM")

The information contained in this SMM reflects changes to the **Rheumatoid Arthritis Step Therapy** and changes to the **Limits on FDA "CLASS II" Pain Medications** information set forth in the SMM mailed to all participants on October 30, 2015, and in the December 2015 Guardian Newsletter.

At the March 8, 2016 meeting, the Trustees of the Central Pennsylvania Teamsters Health & Welfare Fund ("Fund") adopted the following changes:

# **Rheumatoid Arthritis Step Therapy**

The following generic drugs are now added to **the Step I Rheumatoid Arthritis Step Therapy** category:

High dose ibuprofen and naproxen (i.e. requiring an RX), celecoxib, nabumetone, piroxicam, diclofenac, diflunisal, indomethacin, ketoprofen, etodolac, prednisone, cyclophosphamide, cyclosporine, azathioprine and methotrexate.

# Limits on FDA "Class II" Pain Medications

The following changes apply to the Limits on FDA "Class II" Pain Medications:

In cases where patients are taking one or more Class II Pain Medications on an extended basis (i.e. more than 15 days) as part of a physician-monitored pain management program, the Fund Office will require a letter from the treating physician that:

- 1. Explains the condition for which the patient is being treated; and
- 2. Addresses the length of time that the patient has been under their care for said condition; and
- 3. Lists the Class II Pain Medications which are being prescribed to the patient on an on-going basis; and
- 4. Includes a certification by the physician that the treatment plan for the patient is being monitored on a regular basis.

If these four conditions are documented by the treating physician in writing, the Fund can relax the 15 day script requirement and allow the patient to go to a regular 30 day script co-pay schedule for their Class II Pain Medications.

# **STEP THERAPY**

**NOTE:** The medications in each category are subject to change. Please make sure to check with the Fund (Phone: Toll Free in PA: 1-800-422-8330; Toll Free in USA: 1-800-331-0420) or on the Fund's website (www. centralpateamsters.com) for updates to this chart before beginning a course of medication.

Please note: all brand contraceptives are covered under Step II medications and are not subject to grandfathering.

Effective March 8, 2016, the following generic drugs are now added to the Step 1 Rheumatoid Arthritis step therapy: high dose ibuprofen and naproxen (requiring a prescription), celecoxib, nabumetone, piroxicam, diclofenac, diflunisal, indomethacin, ketoprofen, etodolac, prednisone, cyclophosphamide, cyclosporine, azathioprine, and methotrexate

## STEP THERAPY CATEGORIES NOT SUBJECT TO GRANDFATHERING:

Effective January 1, 2016, the Fund will **NOT** provide benefits for medications in Step II unless you have documented that you have tried and failed on a Step I medication and your physician has submitted documentation demonstrating that the Step II medications are "medically necessary" under the Fund's criteria.

Do not pay any balances until after you have received and reviewed the EOB. The estimated balance on a bill generated before the claim is paid by the Fund may not be correct.

Please note: the EOB reflects any co-pay amounts associated with the medical treatment, whether or not the co-pays were actually paid at the time of treatment.

# Routine Physicals at Urgent Care Facilities Not Covered

The Fund has contracted with certain urgent care facilities to cover the treatment of *illness and injuries only*. The Fund has not contracted with any urgent care facilities to cover routine physicals for adults or children. Therefore, the Fund will consider payment for the treatment of illness and injuries at an urgent care facility, but will not pay for routine physicals.

In order to receive Fund coverage for routine physicals for yourself or your eligible dependents, please select treatment with a primary care provider, and not at an urgent care facility.

- Walk-in services are available on a first-come, first-serve basis.
- Coordinated care is available if a specialist is needed.
- A pharmacy and lab are located on-site for your convenience.

# Know Your Health & Welfare Plan

The Health and Welfare Fund frequently receives questions on the topics below. Additional information on these topics is available in your Summary Plan Description or by visiting the Fund website.

- 1. **Dental Implants** All requests for dental implants must be submitted for pre-determination for review under the implant policy. Failure to do so could mean higher out of pocket expenses.
- 2. **Health Savings Accounts for Dependents** If your spouse (or eligible dependent) is covered under a high-deductible health plan with a health savings account (HSA), this spouse or dependent may not be covered under the Central PA Teamsters Health and Welfare Plan. If your employer pays on a Component basis, the Employer will not be responsible for contributions for this spouse or dependent.
- 3. **Motor Vehicle Accidents** -The Fund will consider payment of medical expenses only after the benefits from the auto insurance carrier have been exhausted. In addition, the Fund will not provide coverage for Short Term Disability Benefits (except for the first 5 days of missed work). Contact your auto insurance carrier to make sure that your policy includes payment for missed work due to injuries sustained in an auto accident.
- 4. **Illegal Acts** -The Fund does not cover medical services rendered as a result of your committing an illegal act (misdemeanor or felony). This includes driving while intoxicated (DUI).
- 5. **Change in Family Status** Please review your beneficiary designation if there is a change in your family status. Please notify the Fund if you get married, divorced, are widowed or have a child. The Fund does not allow divorced spouses to continue to be covered under the member's coverage.
- Moonlighting -The Fund does not cover participants or eligible dependents for illness or injuries that occur as a result of performing noncovered employment for wage or profit.
- 7. **Dependent Daughter Pregnancies** -The Fund does not cover medical expenses associated with a dependent's pregnancy.
- 8. **Address Change:** Please remember to contact the Fund office if your address changes.
- 9. **Urgent Care Facilities** coverage for Urgent Care Facilities is for medical conditions only. Physical exams at Urgent Care Failities are not covered.

# HIPAA Privacy Rule Notice

In accordance with the Privacy Rule of the Health Insurance Portability and Accountability Act (HIPAA), the Central Pennsylvania Teamsters Health and Welfare Fund has adopted and implemented policies and procedures that protect your private health information. # The Women's Health and Cancer Rights Act of 1998

Under a federal law called the Women's Health and Cancer Rights Act of 1998, the Fund is required to provide you with an annual notice of your rights under this Act. Please consider this information as the annual notice for 2016 of your rights under this important federal law.

The Women's Healthand Cancer Rights Actrequires the Fund to provide benefits for mastectomy-related services, including reconstruction of the breast on which the mastectomy was performed and surgery to achieve symmetry between the breast, prostheses, and complications resulting from a mastectomy, including lymphedema. Any Fund deductibles and co-payments that apply to other conditions also apply to the treatment related to the mastectomy. You should feel free to contact the Fund Administrator if you have any questions about your coverage. You can reach the Fund Administrator at 610-320-5500.

The coverage is available under all plans of the Central Pennsylvania Teamsters Health and Welfare Fund and is subject to the relevant plan's deductibles and co-insurance provisions.

# **DAVIS VISION NEWS**

#### **Vision Services for Medical Conditions**

Your vision plan through Davis Vision only pays claims for well vision checkups in order to determine the need for glasses or contacts. If you are in need of a vision visit for a medical condition, such as glaucoma, the Fund would consider that visit payable under the medical provisions of your plan. Office visit services provided by a participating provider would be subject to the appropriate specialist co-pay. If the provider that you utilize is nonparticipating, the Fund will pay up to the usual and customary fee minus the appropriate specialist co-pay. If the doctor also performs a charge for a refraction, the refraction would not be payable under the medical provisions of your plan, and would be covered only if you are eligible for vision coverage through the Davis Vision program. Before you decide which provider to utilize, you must consider the reason for which the visit is needed. Please contact the Fund Office if you are in doubt about the network that you should be using to select a provider.

# Vision Works Benefits through Davis Vision

Vision Works' allowance for eyeglass frames is different from other participating vision providers.

Vision Works is a participating provider through Davis Vision for routine eye exams. You will not owe anything for a routine vision exam (adults are eligible every two years; dependent children under 19 are eligible every year). Lenses and coatings are covered the same as other participating providers. As with all Davis Vision providers, there is an 18 month eyeglass breakage warranty and scratch coating warranty included at no additional cost.

Please note that frames are covered differently at Vision Works. Vision Works does not offer Davis Vision's Frame Collection at no cost. At Vision Works, if you select a frame that costs up to \$149.99, the frame is covered in full and you would not owe anything. If you select a frame that costs over \$149.99, the selection is then considered a non-plan frame. There is an allowance of \$90 for a non-plan frame. You would pay the difference between the price of the non-plan frame minus the \$90 allowance.

In order to be sure that you know the cost of your eyeglasses at Vision Works before you make a purchase, please identify yourself as a Davis Vision and Central Pennsylvania Teamsters Health and Welfare Fund participant or dependent when you make your appointment. Vision Works can then verify your eligibility for benefits.

# Know Your Pension Plan

The Pension Fund frequently receives questions on the topics below. Additional information on these and other topics is available by visiting the Pension section of the website. When you are ready to apply for your pension, please refer to the "Important Items to Remember" section of the website under Pension for additional information.

- 1. Beneficiary Updates/Change in Marital Status Please review your beneficiary designation if you change
  your marital status. Please notify the Fund if you get
  married, divorced, or become widowed. If you get
  divorced, please forward a copy of the divorce decree.
  You will need to complete a new beneficiary form for
  your Pension Benefits after your divorce is finalized.
  If you become widowed, you will need to forward a
  copy of the death certificate and also complete a new
  beneficiary form. Downloadable beneficiary forms are
  available on the Fund's website. You cannot name your
  pet as a beneficiary.
- 2. **Retirement Applications** Contact the Pension Fund three months prior to your retirement date to begin the application process (6 months if you have time in another Fund and are applying for a reciprocal pension). The Pension Fund offers appointments to assist you with completing your Application for Pension paperwork. Please be sure to review your benefit options on your paperwork so that you are familiar with them prior to your appointment.
- 3. **Your Retirement Income Plan (RIP) 1987** balance is updated by the 15th of each month and subject to net gains or losses through the last day of the month in which your application is approved for payment.
- 4. **Power of Attorney** If you cannot handle your own affairs, you must provide the Fund with a Durable Power of Attorney before any information can be given to the person who you designate to handle your affairs.
- 5. **Pension Checks** Your checks from the Defined Benefit Plan (or monthly installments from the Retirement Income Plan if elected) are dated the first of each month. If you elect direct deposit, your check will be deposited on the first business day of the month. For example, if the first of the month falls on Sunday, your check will be deposited on Monday.
- 6. **Website** Please visit the website for Summary Plan Descriptions, Forms and Notices, Important Items to Remember or to view your RIP 1987 balance.
- 7. **Signatures on Fund Documents** Please sign all Fund documents with your legal name, which must match what is on file with the Fund Office. Please be sure to use your full name (no nicknames) and suffix (Jr., Sr., III), if applicable.



# PENNSYLVANIA ADVANCE CARE DIRECTIVE AND LIVING WILL

Note: The following is not a substitute for legal advice. The information below pertains to the state of Pennsylvania only. Rules vary by state. Contact your attorney if you need additional information.

You have the right to decide the type of health care you want. Should you become unable to understand, make or communicate decisions about medical care, your wishes for medical treatment are most likely to be followed if you express those wishes in advance by:

- (1) naming a health care agent to decide treatment for you; and
- (2) giving health care treatment instructions to your health care agent or health care provider.

An advance health care directive is a written set of instructions expressing your wishes for medical treatment. It may contain a health care power of attorney, where you name a person called a "health care agent" to decide treatment for you, and a living will, where you tell your health care agent and health care providers your choices regarding the initiation, continuation, withholding or withdrawal of life-sustaining treatment and other specific directions.

You may limit your health care agent's involvement in deciding your medical treatment so that your health care agent will speak for you only when you are unable to speak for yourself or you may give your health care agent the power to speak for you

immediately. This combined form gives your health care agent the power to speak for you only when you are unable to speak for yourself. A living will cannot be followed unless your attending physician determines that you lack the ability to understand, make or communicate health care decisions for yourself, and you are either permanently unconscious or you have an end-stage medical condition, which is a condition that will result in death despite the introduction or continuation of medical treatment.

You, and not your health care agent, remain responsible for the cost of your medical care. If you do not write down your wishes about your health care in advance, and if later you become unable to understand, make or communicate these decisions, those wishes may not be honored because they may remain unknown to others.

A health care provider who refuses to honor your wishes about health care must tell you of its refusal and help to transfer you to a health care provider who will honor your wishes. You should give a copy of your advance health care directive (a living will, health care power of attorney or a document containing both) to your health care agent, your physicians, family members and others whom you expect would likely attend to your needs if you become unable to understand, make or communicate decisions about medical care. If your health care wishes change, tell your physician and write a new advance health care directive to replace your old one. It is important in selecting a health care agent that you choose a person you trust who is likely to be available in a medical situation where you cannot make decisions for yourself. You should inform that person that you have appointed him or her as your health care agent and discuss your beliefs and values with him or her so that your health care agent will understand your health care objectives.

You may wish to consult with knowledgeable, trusted individuals such as family members, your physician or clergy when considering an expression of your values and health care wishes.

# **DELTA DENTAL NEWS**

#### **Dental Predetermination**

Predetermination enables you and your dentist to know in advance what the Delta Dental payment will be for any service that may be in question.

Delta strongly recommends a predetermination if total charges are expected to exceed \$300.

Your dentist should submit the pre-determination request before performing services.

Delta acts promptly in returning the predetermination voucher to your dentist (with a copy to you), explaining patient eligibility, scope of benefits, and the period of time for completion of services.

Delta's payment of the predetermined amount is dependent upon continued participant eligibility. Payment may be reduced due to coordination of benefits with other coverage for which the patient is eligible.

Once the service is completed, a claim with service dates and signatures should be submitted to Delta for prompt payment.

#### Where's My Dental ID Card?

If you've been looking for your dental plan ID card, we have good news for you: You don't need one!

When you visit the dentist, simply tell the dental office staff that you are covered by Delta Dental. You will need to provide the following information:

- Your name
- · Your date of birth
- Your enrollee ID number as issued by the Fund and as printed on your medical ID card issued to you by the Fund

If you are covered through your employer, you may also be asked the name of your company. Family members covered under your plan will be required to provide your details.

#### Want an ID card anyway?

On your computer:

 Go to deltadentalins.com, and log in to Online Services. (Click Register to sign up if you haven't already.) Click on My ID card in the left column. A new window with your ID card should pop up, which you can print out for your records. (If nothing happens, check whether your browser is blocking pop-ups.)

On your smartphone:

 Go to deltadentalins.com, log in to your account and select My ID card from the main menu. You can pull up this electronic ID card at your dental office.

#### Dental Benefits on the Go!

 Delta Dental's free mobile app gives you access to recent claims and coverage information from the convenience of your phone. You can also access your ID card. Looking for an in-network dentist? The app can help. Search for a dentist by network, dental specialty, location or a provider's last name. And by clicking on a dentist's name, you can view additional information, add the dentist to your contacts and even get directions to the dental office.

# VITAMINS THAT MAY REDUCE CANCER RISK

A healthy diet serves as a potent weapon in the battle to ward off cancer. Though researchers still have much to learn about the best foods to include, they've found a few specific nutrients that may reduce your risk for malignant tumors. Shore up your defenses with:

**FOLATE** – Some studies suggest getting enough of this B vitamin helps prevent colorectal, lung, pancreatic, breast and other cancer. One way it may work: by preventing abnormal cell division, which is the hallmark of cancer cells. You can find vitamin B in spinach, black-eyed peas, asparagus, Brussels sprouts, and romaine lettuce.

VITAMIN C – Early research suggests people who get enough of

this immune-boosting nutrient from fruits and veggies have a lower chance of developing lung, breast and colon cancer. Red peppers serve as a one of the best sources – just half a cup of this raw, sweet veggie boasts more than 150% of your daily needs! Also peel some citrus fruits, slice some strawberries, or steam some broccoli – they're also rich in vitamin C.

**VITAMIN D** – Researchers noticed something interesting when they looked at geography and cancer risk. People in southern latitudes – where sunlight is more abundant – showed lower rates of developing and dying from some cancers. Since human skin produces vitamin D in response to sunlight, they hypothesized this nutrient may play a role in cancer prevention. So far, lower rates of colorectal, breast, prostate, and pancreatic cancer have been linked to getting enough vitamin D. To boost your intake, eat fatty fish like salmon and tuna, drink fortified milk or orange juice, or crack open some eggs. Even though sunlight and skin means more vitamin D, limiting sun exposure and using sunscreen on both sunny and cloudy days helps prevent common forms of skin cancer. Take a vitamin D supplement if you need to boost your levels.

**VITAMIN E** – This nutrient acts as an antioxidant, repairing damage to cells that occur over time. As a group, antioxidants may play a role in reducing cancer risk. But while scientists once thought vitamin E might ward off prostate cancer, studies have found evidence that vitamin E supplements can actually boost men's odds of developing this disease. Food sources of this nutrient, though, can fit into a healthy diet. Try almonds, peanut butter, sunflower seeds, and boiled spinach.

**YOUR COMPLETE CANCER-FIGHTING DIET** – Always talk to your doctor before taking supplements – if you're already getting enough of a particular vitamin, they could hurt instead of help your health. For the greatest protection against cancer and other health problems, focus on your overall dietary pattern. Eating more fruits and veggies, less red and processed meats, and drinking less alcohol may be the smartest moves to stay cancer-free.

Zika is a virus that is spread by mosquitoes. A pregnant mother can pass it to her baby during pregnancy or around the time of birth. There have also been reports that the virus has spread through blood transfusions and sexual contact. There have been outbreaks of Zika virus in Africa, Southeast Asia, the Pacific Islands, parts of the Caribbean, and Central and South America.

No local mosquito-borne Zika virus disease cases have been reported in US states, but there have been travelassociated cases.

With the recent outbreaks, the number of Zika cases among travelers visiting or returning to the United States will likely increase. It is predicted that 80% of cases will not be diagnosed. These imported cases could result in local spread of the virus in some areas of the United States.

Most people who get the virus do not get sick. One in five people do get symptoms, which can include a fever, rash, joint pain, and conjunctivitis (pinkeye). Symptoms are usually mild, and start 2 to 7 days after being bitten by an infected mosquito.

A blood test can tell whether you have the infection. There are no vaccines or medicines to treat it. Drinking lots of fluids, resting, and taking acetaminophen might help.

There have been reports of microcephaly (a serious birth defect of the brain) and other problems in babies whose mothers were infected while pregnant. The Centers for Disease Control and Prevention recommends that pregnant women do not travel to areas where there is a Zika virus outbreak. If you do decide to travel, first talk to your doctor. You should also be careful to prevent mosquito bites:

- Use insect repellent
- Wear clothes that cover your arms, legs, and feet
- Stay in places that have air conditioning or that use window and door screens
