

### Letter from the Central Pennsylvania Teamsters Pension Fund Board of Trustees:

"...we are instituting improvements designed to make a system that is already very good even better." Dear Participants in the Central PA Teamsters Pension Fund:

A s part of the s e t t l e m e n t agreement of March 19, 2006 resulting from the lawsuit of Drake Saxton, Jimmy Little, Thomas C. Dudley, vs. Central Pennsylvania

Teamsters Pension Fund, Trustees, & Administrator, it was concluded that an independent, experienced and competent financial services organization assist the Fund in evaluating various aspects of the Fund's operation and investment program.

The Trustees of the Fund and the Saxton plaintiffs agreed to select Independent Fiduciary Services, Inc. (IFS) to conduct this evaluation. Both sides chose IFS because the firm has an excellent reputation, having over twenty years of experience in conducting operational reviews of pension plans throughout the United States. Everyone connected with the Saxton litigation viewed IFS as having the fairness and expertise necessary to conduct this evaluation of the Fund's investment practices.

The extensive list of items reviewed included the following: Investment Policy, Asset Allocation, Retainer Consultant's Responsibilities, Investment Management Structure, Investment Performance, Investment Reporting and Monitoring, Performance Benchmarks, Due Diligence Procedures, Costs and Fees, Investment-related Organizational Structure and Actuarial Review-Mortality Assumptions.

The Board of Trustees fully cooperated with IFS. The Fund staff spent several days compiling responses to the detailed questions and document requests. In addition, both Trustees and staff members participated in interviews in which they answered all questions posed by representatives of IFS.

IFS issued its first final report concerning evaluation of the Fund's investment practices in December 2006. So that there is no misunderstanding as to IFS's basic conclusion, we shall quote the following language found on page 3 of the IFS report:

"The results of this review demonstrate that the Fund is generally in line with best practices in terms of much of its investment program and many of our recommendations should be considered as enhancements or a recommendation that current practices be continued in the future."

are currently studying the various We recommendations contained in the IFS report and adopting most of we anticipate these recommendations. However, we ask you to remember the "bottom line" of the IFS report the majority of the Fund's policies are already in line with the "best practices" for investing. Therefore, any changes that we adopt are not radical departures from what we are already doing. Rather, we are instituting improvements designed to make a system that is already very good even better.

The Agreement calls for IFS to provide a "Second Report" and a "Third Report" evaluating whether the Fund and its Board of Trustees have implemented the recommendations made in the First Report and whether the implementation steps and status seem reasonable. The Second Report is scheduled for approximately 18 months after the First Report and the Third Report is scheduled for approximately 18 months after the Second Report is submitted.

This process was expensive. IFS's fee for conducting this review will ultimately amount to \$300,000. This does not include the staff time, *(Continued on page 2)*

the cost of photocopying dozens of documents, and other costs of compliance with the requests. We regret that the Saxton plaintiffs made us undergo this review as part of the steps needed to end their litigation, because we believe that the money could have been better used to pay for pension benefits for our participants and beneficiaries. However, most of the review process is complete and we are heartened that IFS, an objective outside observer with well-established credentials, has recognized that our investment program is in line with what it describes as the "best practices."

Last year, our investment managers posted returns for the Defined Benefit Plan of 16.6%, for RIP 1987 of 16%, and for RIP 2000 of 14.1%. We think that these returns, which surpassed both the relevant benchmarks and the returns of other Teamsters plans with which we are familiar, provide further evidence that our investment program is in line with the "best practices." We shall work hard to keep this record intact.

## **Please note:**

Collecting Health & Welfare or Pension benefits using false or misleading information is considered to be fraud by the Fund Office. Some examples of this would be: a dependent continuing medical coverage after he or she is no longer eligible for benefits (such as in the case of a divorce) or an individual who collects a deceased retiree's pension benefits without notifying the Fund Office of the retiree's death. The Fund Office must be notified of any active or retired member's divorce or death as soon as possible.

Any benefits which are paid based on misleading information or a misrepresentation of information must be repaid to the Fund. The Fund reserves the right to prosecute to the fullest extent of the law.

## Is Your Pension Plan Beneficiary Designation Current?

If you have had a change in marital status, you may need to update your beneficiary information. I f you are covered under the Central P e n n s y l v a n i a Teamsters Pension Plan, you should have completed a Designation of Beneficiary form when you first became eligible for employer contributions to the Central

PA Teamsters Pension Fund. Have you kept your beneficiary information up-to-date? If you have had a change in marital status, you may need to update your beneficiary information. The forms are available on the Central PA Teamsters website www.centralpateamsters.com or by contacting the Pension Department.

## Emergency Room Co-pay Goes Into Effect on July 1, 2007

Please remember that, effective July 1, 2007, there is a \$50 co-pay for emergency room visits. The co-pay is waived only if admitted. New insurance ID cards were mailed to members that included the co-pay information. Please replace your old card with the new one if you have not done so already. Contact the Health & Welfare Department if you did not receive your new insurance ID card.

### March 31, 2007 Retirement Income Plan Returns

The following are approximate net returns for the Central PA Teamsters RIP 1987 and RIP 2000 retirement plans for the 3 month period ending March 31, 2007. The net returns equal gross investment returns less investment and administrative expenses plus the reallocation of forfeited account balances from terminated non-vested participants who incurred a 5-year break in service.

# **Suspension of Benefits Q&A**

As was noted in the March, 2007 edition of the *Guardian*, a new Suspension of Benefits notification procedure was approved by the Board of Trustees on February 22, 2007. The Fund Office has received many inquiries recently about the new notification procedure as well as the Suspension of Benefits rules. The following is a description of the Suspension of Benefits rules as well as of the new policy in a question and answer format. If you have further questions, please contact the Pension Department.

What are the Suspension of Benefits Rules?

The complete Suspension of Benefits rules can be found under the Pension section of the Central Pennsylvania Teamsters website **www.centralpateamsters.com**. The following is a summary of the rules:

Retirement benefits may be suspended during any period in which a retired employee returns to active service under certain circumstances with certain employers described below. Specifically, if you are under age 70<sup>1</sup>/<sub>2</sub>, your monthly pension benefits may be suspended for any month in which you:

- Are paid more than 56 hours. However, the 56hour limit does not include pay for vacation, sick time, holidays, disability or severance.
- Worked in the same trade or craft that you worked as a Teamster, and
- Worked in the same geographic area covered by the Pension Fund, regardless of whether the pay is for working or non-working hours.

In addition, effective June, 2003, the Fund will not suspend the benefits of individuals who have attained age 67, have participated only in the Fund's Defined Benefit Plan, and whose total monthly benefit does not exceed \$150. This rule applies only to individuals who work for a contributing employer in a position for which contributions to the Fund are not required.

Also, effective June 2004, the Fund will not suspend the portion of a retired employee's benefits that were earned prior to January 1, 1987 unless the retired employee is working for an employer that is a successor to such employer or an affiliate of such an employer.

What Benefits Fall Under the Suspension of Benefits Rules? Retirement benefits payable under Central Pennsylvania Teamsters Defined Benefit Plan, Retirement Income Plan 1987 and Retirement Income Plan 2000 fall under the Suspension of Benefits Rules.

*How Has the Suspension of Benefits Notification Policy Changed?* 

**Old Policy:** Prior to February 22, 2007, the Fund Office required that retired employees notify the Fund Office if they are working or intend to work in order to determine if the work is in violation of the Suspension of Benefits rules. In addition, prior to February 22, 2007, the Fund Office randomly selected and contacted retirees to complete a questionnaire in order to determine if these individuals were complying with the Suspension of Benefits Rules.

**New policy:** Retired employees are still required to notify the Fund Office if they are working or intend to work in order to determine if the work is in violation of the Suspension of Benefits rules. Beginning on February 22, 2007, however, and every year thereafter, affected retired employees will be mailed an Annual Employment Certification form, which they will be asked to complete and return. A portion of these mailings will be sent each month until all affected retirees have been contacted.

What is the Fund Office Notification *Procedure?* 

Retirees who are subject to the Suspension of Benefits rules will be mailed an Annual Employment Certification form every year. The Fund Office requests that the forms be completed and returned within 30 days. If the Fund Office does not receive the completed form within 30 days, a second form will be mailed. If the second form is not completed and returned within 15 days, the affected retiree will be notified that their benefits will be suspended.

# What is the Fund Office Suspension *Procedure?*

**IMPORTANT.** *Please note:* If the Annual Certification Form is not returned within the time frame noted above, or if it is determined that a retired employee is in violation of the Suspension of Benefits rules, benefits will be suspended and will remain suspended until the Fund Office determines that the retired employee is no longer working in suspendible employment.

## Employer Group Coverage Requirements under USERRA

The Uniformed Services Employment and Reemployment Rights Act (USERRA), prohibits discrimination against persons because of their service in the Armed Forces Reserve, the National Guard, or other uniformed services.

USERRA requires that employees who are called up to active service and who are eligible for their employer's group health coverage must be allowed to continue their health coverage for themselves, their spouse and their dependent children. Individuals electing continuation of coverage on or after December 10, 2004 can elect coverage for up to 24 months. Prior to December 10, 2004, eligible individuals could elect coverage for up to 18 months.

The Act also requires that your employers provide an annual notice of USERRA rights and obligations to employees entering military service. This notice requirement can be met by posting the notice in a location where the employer customarily places notices to employees. The requirement also applies to unions that operate hiring halls.

Please call your employer or the Fund Office if you have questions about your USERRA rights.

## The Women's Health and Cancer Rights Act of 1998

Under a federal law called the Women's Health and Cancer Rights Act of 1998, the Fund is required to provide you with an annual notice of your rights under this Act. Please consider this information as the annual notice for 2007 of your rights under this important federal law.

The Women's Health and Cancer Rights Act requires the Fund to provide benefits for mastectomyrelated services, including reconstruction of the breast on which the mastectomy was performed and surgery to achieve symmetry between the breasts, prostheses, and complications resulting from a mastectomy, including lymphedema. Any Fund deductibles and co-payments that apply to other conditions also apply to the treatment related to the mastectomy. You should feel free to contact the Fund Administrator if you have any guestions about your coverage. You can reach the Fund Administrator at 610-320-5500.

This coverage is available under all plans of the Central Pennsylvania Teamsters Health and Welfare Fund and is subject to the relevant plan's deductibles and coinsurance provisions.

# Ready to Quit Smoking?

Certain prescription smoking cessation treatments are covered under the Central PA Teamsters Health & Welfare Fund's prescription plan through General Prescription Programs (GPP). Some brands of smoking cessation medication also provide access to support programs as part of the cost of the prescription medication. Ask your doctor if you are a candidate for smoking cessation prescription medication and ask about any support programs which may be offered when purchasing the medication.

# **Death Benefits Improved Effective July 1, 2007**

Effective on July 1, 2007, the Fund's Death and Accidental Death and Dismemberment Benefits are insured by Aetna.

Also effective July 1, 2007, the Death and Accidental Death and Dismemberment Benefits was increased for those participants covered under Plan 13 and participants who have the Optional Death and Accidental Death and Dismemberment Benefit coverage under Plan 14.

For those covered under Plan 13 and Plan 14 Option A, the Death and Accidental Death and Dismemberment Benefit was increased from \$25,000 to \$35,000. For those covered under Option B, benefits have been increased from \$15,000 to \$20,000. For those covered under Option C, benefits have been increased from \$7,500 to \$10,000.

In addition, Death Benefits for dependent children was increased from \$1,000 to \$2,000. Death Benefits for a spouse remains at \$2,000.

Aetna's death benefit coverage includes:

- Death due to accidental exposure or disappearance
- Coma Benefit
- Child Care Benefit
- Education Benefit for child/spouse
- Seatbelt and Airbag Benefit
- Accelerated Death Benefit
- Repatriation of Remains Benefit (200 or more miles from home)

Aetna's dismemberment benefit coverage includes:

- Sight, Speech and Hearing
- Quadriplegia, Paraplegia, Hemiplegia, and Uniplegia
- Third degree burns

Aetna also offers a Legal Reference Program, **www.ichooselegal.com**, to participants and their immediate family members. The program offers free access to a glossary of legal terms and access to web sites that focus on popular areas of law. The sites provide information on a variety of legal topics that include:

- Adoption
- Consumer protection
- Debt collection
- Estate planning
- Identity theft
- Immigration
- Tax/IRS issues

The program also provides users with the ability to create a free Living Will and offers free Health Care and Durable Financial Power of Attorney forms through the www.ichooselegal.com website.

In addition to the above, members and their spouses are entitled to Basic Will preparation services via the website at no cost.

### Student Verification Letters Due to the Fund Office by September 30, 2007

Eligible dependent children 19 years of age or older who are full-time students may continue their Health & Welfare coverage until the end of the month following their 23rd birthday provided proof of full-time enrollment is received by the Fund each year from the school they are attending. Students may not continue Health & Welfare coverage if they are employed full-time (with the exception of summer employment).

**Important:** Please contact the institution of higher learning at the start of the fall semester to have this information forwarded to the Fund Office by September 30, 2007. Failure to provide this information to the Fund by September 30, 2007 will result in the cancellation of benefit

coverage for this dependent. The dependent will then be offered COBRA continuation coverage in accordance with federal law.

If at any time your child stops attending school or is no longer considered an eligible fulltime student, pleased contact the Fund Office immediately. Coverage ceases when the student is no longer attending school full-time. If benefits are paid by the Fund on behalf of the dependent after they are no longer considered a full-time student, a refund of all benefits paid after that date will be requested.

If you have any questions, please contact the Contributions/Eligibility Department at the Fund Office.

# **Moonlighting/Self-employment**

The Fund does not cover participants or eligible dependents for illnesses or injuries which arise as a result of performing non-covered employment for wage or profit. Any time a service is rendered for wage or profit, there are no benefits **(i.e. medical, short-term disability, etc.)** payable by the Fund. Non-covered employment means any employment for which contributions are not made to the Fund. Unfortunately, in the past, there have been cases where the individual was performing odd jobs, i.e. painting, roofing, etc. for which services they received payment. The individual was then injured while performing the job and as a result all bills and short-term disability benefits were denied. If you or your spouse intend to render services or be self-employed in any capacity for which a wage or profit is received, you must have the appropriate liability coverage to



cover any injuries or illnesses which arise as a result of performing such services.

You should contact your motor vehicle insurance carrier to evaluate the extent to which you are covered for wage loss benefits as a result of a motor vehicle accident.

'here is a misconception with regard to the coverage provided by the Fund when the claim is the result of an injury due to a motor vehicle accident. accordance with In Plan provisions, the Fund will **only** cover medical expenses on a subrogated basis once the maximum liability has been paid by the

motor vehicle insurance carrier. The Fund will **not** provide coverage for short-term disability benefits (except for the first 5 days of missed work). The only time the Fund will pay more than 5 days of short-

term disability is when written proof is submitted verifying that the state in which you reside does not allow you to purchase wage loss protection from your motor vehicle insurance carrier. Check with your motor vehicle insurance carrier to ensure that your policy carries at least the minimum coverage required by the state in which you reside. In addition, the Fund Office recommends that you contact your motor vehicle insurance carrier to evaluate the extent to which you are covered for wage loss benefits as a result of a motor vehicle accident. Do not wait until you have an accident to find out you have no wage loss coverage under your policy. Payment for the first 5 days of short-term disability benefits does **not** apply to motorcycle accidents. There are **no** short-term disability benefits payable for injuries sustained as a result of a motorcycle accident.
