This is a summary of the annual report for the Central Pennsylvania Teamsters Health and Welfare Fund, Employer Identification Number 23-6263170, Plan No. 501, for the period January 1, 2018 to December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

INSURANCE INFORMATION

The Fund has a contract with the Hartford Life and Accident to provide certain benefits. The premiums paid under the contracts for the year ended December 31, 2018 were \$456,550.

SELF ADMINISTERED INFORMATION

The Fund provides certain medical, prescriptions, disability, vision, dental, hearing, mental, drug, alcohol, physical therapy, transplants, and childhood immunizations claims incurred under terms of the plan. The Fund self pays these benefits, which totaled \$105,021,992 during the year ended December 31, 2018.

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$114,335,762. These expenses included \$6,503,990 in administrative expenses and \$107,831,772 in benefits paid to participants and beneficiaries.

The value of plan assets, after subtracting liabilities of the plan, was \$99,567,889 as of December 31, 2018 compared to \$99,259,270 as of January 1, 2018. During the plan year, the plan experienced an increase in its net assets of \$308,619. This increase includes unrealized

appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the plan's assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$114,644,381 including employer contributions of \$115,458,789, employee contributions of \$5,222,806, realized gains of \$1,805,252 from the sale of assets, earnings (losses) from investments of (\$8,707,642) and other income of \$865,176.

YOUR RIGHTS TO ADDITIONAL INFORMATION

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- 2. financial information and information on payments to service providers;
- 3. assets held for investment;
- 4. transactions in excess of 5% of plan assets; and
- 5. insurance information, including sales commissions paid by insurance carriers

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
