Summary of Material Modification PLAN 13Y

Please Note: Due to a subsequent change adopted by the Board of Trustees at their June 9, 2021 Meeting, this Summary of Material Modification ("SMM") replaces the prior SMM notification stating that Dental benefits were adjusted to 80% of the contracted rate up to \$800 per person effective January 1st 2021.

The Trustees are pleased to present you with a summary of the improvements made to your benefit plan. Please review each of the changes carefully. This change applies to covered dental service for which claims were incurred on or after January 1, 2021.

1. **Dental Benefits:** Section 9.1.c. (Benefits Limits): This section is amended by increasing the Dental Benefits for Routine and Accidental Services as follows:
 - a. **Network Provider:** The Fund will pay Benefits of 100% of the contracted rate up to \$1000 per person per Benefit Year. Previously, the Benefits were up to 80% of the contracted rate up to \$800 per person per Benefit Year.
 - b. **Non-Network Provider:** The Fund will pay Benefits of up to 100% of the UCR, up to \$1000.00. Previously, the Benefits were up to 80% of the contracted rate up to \$800 per person per Benefit Year.

If a Participant or Dependent has a remaining balance for covered dental services performed in 2021 due to reaching their \$800 maximum, he or she can submit the claims for the remaining \$200 balance to the Fund for consideration of payment of the additional \$200 to reach the \$1000 maximum.
